# **Course Description**

This is an introductory online course to Russian language and culture. It assumes no previous knowledge or study of the language.

# **Course Objectives**

In this online course, you will work on developing the ability to communicate, which includes:

- comprehending spoken Russian
- hearing, reading, and understanding the story of four American students abroad
- reading authentic Russian texts and websites
- speaking and writing (typing and by hand) Russian on basic personal and everyday topics
- understanding salient aspects of Russian culture and everyday life
- understanding and applying the fundamentals of the Russian grammatical system.

### **Study Tip**

The *Mezhdu nami* website contains a large number of audio recordings integrated into the webpage pages. These audio recordings give you a model for how words and phrases are pronounced in Russian. The first time you work with a new text, listen to the recording as you read it. Notice how the speakers pronounce the words. Work through the text, making sure that you understand the words and the situation. Put a "?" by any parts that don't make sense, so you can ask your instructor about them. When you have really got a handle on the text, close your eyes and listen to the episode again. As you listen, can you "see" the words that you are hearing?

- 2. Please be also advised that when you turn in Google translation as your own work, you are committing academic misconduct. Moreover, Google Translate's results are often wrong, so do not rely on the results from online translators.
